

Groundwater Protection Scheme



Does your home or property fall under the **Groundwater Protection Scheme** as stipulated under the Cardiff Bay Barrage Act of 1993?

Schedule 7 of this Act provides protection for properties that fall within the scheme. The Groundwater Property Protection Scheme allows you, the owner or occupier, to raise issues relating your property and the impoundment of Cardiff Bay in 1999.

Please note the Groundwater Property Protection Scheme will cease to be available from 3 November 2019.

In order for Cardiff Harbour Authority to provide an efficient service, the City has been divided into a number of districts (see boundary areas and dates on the map).

Owners and occupiers of buildings within the boundary are asked to take note of the information contained in this leaflet and to be advised that additional information will be made available on www.cardiffharbour.com

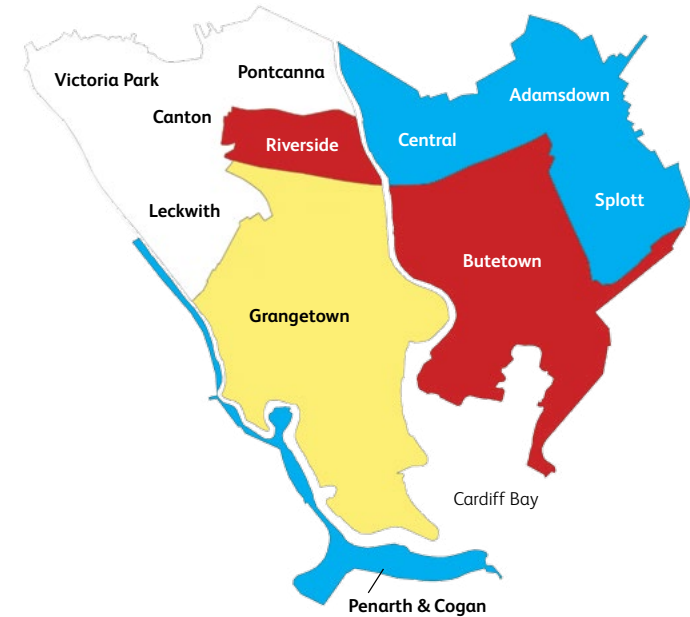

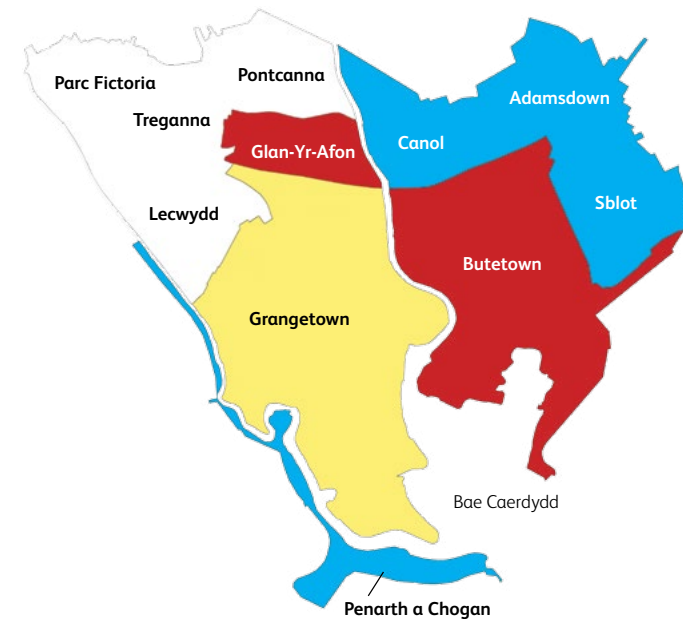
